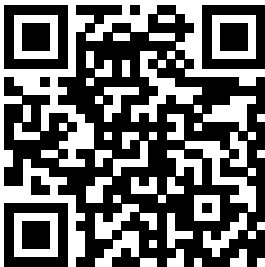

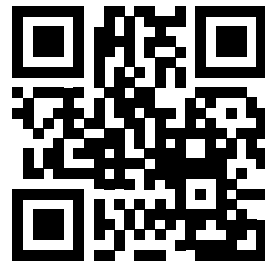
Pictures this month are of the BIALL Quiz Night which was ably run by John Evans with the splendid support of the Professional Development Committee.
